About the United Utilities Trust Fund

United Utilities Trust Fund is a Registered Charity that was established to help people facing hardship and unable to meet the cost of water and sewerage charges. It receives generous funding from United Utilities Group plc with policy and grant-making overseen by a Board of six independent Trustees who ensure that the money goes where it is most needed.

The Trust aim is to support people experiencing crisis situations by making grants available to help them pay their outstanding water charges and other priority bills to encourage future financial stability. In some cases we can give further assistance by providing essential household items such as white goods and beds.

Trustees recognise that the reach of the Trust can be extended by supporting local organisations to provide money advice services within the community and each year they fund projects that can deliver these services to individuals that are free-of-charge to individuals who need them.

Chair's Report

On behalf of the Trustees of United Utilities Trust Fund, I am delighted to present our Annual report for 2015/ 16 that demonstrates how we help people in the most difficult situations.

Trustees recognise that without the generous donations received from United Utilities Trust Fund which totalled £6.2m this year, their work could not continue and we wish to thank them for their ongoing commitment.



In 2015/16 this support has enabled the Trust to assist 5,486 individuals and families who are in financial hardship by providing grants amounting to £5.2m.

Although our grant making is focussed on helping people meet the costs of water charges, the Trust offers much needed help with other household bills. We also understand the impact we can have on a person's quality of life by providing items such as cookers, washing machines and beds which most of us take for granted.

The Trust also helps in local community organisations who can deliver advice that helps individuals to resolve their debt and money issues. This work has expanded the reach of the Trust into some of the most deprived areas in the North West. During the year United Utilities Trust Fund continued to fund 11 organisations to deliver these services and designated £339,423 to be utilised for new projects.

Changes to the welfare benefits system have affected many individuals and families in the region and household budgets are increasingly coming under pressure. With the continued support of United Utilities Water, Trustees look forward to being able to assist more people in 2016/17 who are in need of our help and support more organisations to provide debt and money advice services.

On behalf of Trustees I would like to thank all the advisers working in local community organisations who help alleviate the hardship experienced by their service users. We encourage them to continue to use the Trust in the future.

There are many others who support the work of the Trust and I would like to thank Auriga Services who administer the Trust so competently and my fellow Trustees who give their time and expertise freely. As Chair of the Trust I sincerely value their support and commitment.

Further Assistance Programme

The trust's main focus is to help people with grants towards their water debt but we believe that providing further assistance to individuals who need immediate support with priority bills or essential household items is a vital part of our work.

This year Trustees were pleased to give **1,634 grants** for further assistance which totalled **£338,044**.

The majority of grants provided essential household items such as cookers, fridges, washing machines and beds.
